March Demo - Paul Bachem - March 4th

Paul Bachem studied with Harold R. Stevenson and Alma Gallanos Stevenson and enjoyed a 30-year illustration career. He worked for clients in New York City, across the country and as far away as Sydney, Australia. Paul's paintings are in numerous private collections as well as the permanent collection of the Forbes Gallery in New York City. He now concentrates on plein air painting and has shown at a number of galleries in the Northeast. Paul was named "Best in Show" at the first annual Northport Plein Air Event.

has been included 18 times in the FAV 15% of entries in the Bold Brush monthly painting competition and in October of 2011 was awarded a finalist award by judge Matt Smith. Paul has participated as a competition artist in a number of plein air events including the 2011 and 2012 Wayne Art Center Plein Air Event in Wayne, PA, Paint The Town, 2011 in Cranford, NJ, where he was awarded 3rd prize. Paul has also participated in the prestigious Plein Air Easton in Easton, MD

in 2010, 2011 and 2012 when he was awarded the Utrecht Award of Excellence for "Best Use of Light". Paul teaches at The Art League of Long Island in Dix Hills, NY.

Aside from painting, Paul enjoys playing classical guitar and chess. Of the three he is considered to be a very talented painter! He lives and works in Locust Valley, New York with his wife Janice, herself a talented painter and sculptor.

February Demo - Bart DeCeglie



Our demo in January was well attended. Certainly this was due to the reputation of our demonstrator, Bart DeCeglie. He was up to his fine reputation as an excellent artist and a great instructor.

He worked quickly, was clear in his instruction – gave many hints and tricks to improve the outcome of work of art. He has a wit about him that was engaging and pleasant; it was a joy to be part of the fine demo given by Bart DeCeglie.

Bart chose his work from a photo that he had taken in Oyster Bay. One of the first points was that when painting from a photo one must look for the part of the photo that has the most potential to attract the viewers eye. To emphasize this he chose a mat that would eliminate elements of the photo that were less interesting. Bart put a

grid on the photo as well as on the canvas – by dividing both into fourths. By doing this he was more in control of getting the layout of the painting in the perspective of the photo. He chose and recommended that the artist then do a rough sketch of the painting on the canvas using a brush and a neutral color.

When the sketch was completed he proceeded to paint the big shapes first, the sky, the hills in back, the water, shadows, etc. His technique was unique it seemed to me, scrubbed with the brush to create these larger shapes.

He then worked on the finer parts of the painting emphasizing the importance of color, light, shadows and the center of interest. He was relentless in his endeavors to create a painting that best represented his diligence for "good art". He had succeeded! A raffle was held for the painting and I was fortunate to be the lucky winner.

Grand Ceremonial Bonfire?

Recently, Herb Parsons of North Haven, Maine, USA wrote, "It has come to my attention that, at 75, I may not live forever. I recently sold my gallery/gift shop/studio of 28 years and, though my work has enjoyed a modestly steady market, I'm nonetheless faced with storing a lifetime of paintings, drawings and sculpture. How do artists deal with these unsold treasures? Must I face up to some sort of Grand Ceremonial Bonfire?"

Thanks, Herb. From what I can see, most of your work is not for burning. Your plan should be to extend your work's posthumous reach and value through an orderly and calculated distribution, both for the benefit of mankind and for your heirs. Here's what you need to do:

Take a hard look at your work and separate your substandard from your best. So they're off the market forever, go ahead and have a private GCB for the baddies only. With a paragraph in your will, assign your painting estate to a key manager who is (ideally) a knowledgeable and trusted offspring or other caring family member--preferably of the next generation and not necessarily your executor. Also, request, with prior permission, the down-stream consultation (pricing, distribution, promotion) of two or three trustworthy art dealers or marketers who may be in a position to do something with your work. You may also suggest your key manager consult with others unknown to you.

Your key manager, working with your executor, should have the power to release work in a timely manner--over a period of years, if necessary. Your elected dealers, to be effective, need to be given a certain amount of control, long-term security and monetary benefit. Appointing several dealers is preferable than just one. Your will should also stipulate that your key manager is also an heir and any distributions coming via him or her will be by a fore-ordained formula and for the benefit of all heirs.

Many artists find this sort of planning difficult. Fact is many artists leave an appalling mess--a disservice both to their art and their family.

Herb--think about choosing a key manager, talk to potential dealers and see a lawyer to clarify your plan. In the meantime, store your art in a clean, dry place. Oh, and, by the way, get a larger space than you think you'll need--over the next 30 years you may be adding even better work to your legacy.

Esoteric: You can gradually reduce your storage requirements by judiciously giving works to charities, fundraisers, friends and relatives. Don't give anyone the idea that you're trying to get rid of things. Never, ever, in any circumstances have a clear-out, garage, or half-price sale. Your work has value and you need at all times to mete it out wisely and in a dignified manner.
